Introduction:

Skillinvest is committed to eliminating unlawful discrimination, workplace bullying, sexual harassment and victimisation through modelling inclusive leadership, and promoting an inclusive and respectful workplace culture where people feel safe and valued.

Application

This policy applies to all workers, including full-time, part-time and casual employees, as well as temporary staff, contractors, volunteers and consultants employed or engaged by Skillinvest. The policy also applies to visitors and other personnel present on Skillinvest work premises or using its facilities with its employees, contractors or consultants.

Policy

All employees are expected to uphold Skillinvest's diversity and inclusion principles.

1. Skillinvest respects and values the diversity of all employees, clients, business partners, volunteers and stakeholders.
2. Aboriginal and Torres Strait Islanders are recognised as the nation's First Peoples and their cultures and contributions are acknowledged.
3. Skillinvest respects all genders, sexes and sexualities.
4. Skillinvest promotes an inclusive workplace where diversity and equal opportunity is valued.
5. All employees have the right to be treated with respect, equity and dignity.
6. All employees will be recognised and valued for their diversity and contributions.
7. Fair and equitable recruitment and selection is reflected by attracting and retaining employees from broad cultural and diverse backgrounds wherever possible.
8. Employees are encouraged to exercise their right to practice and express their own culture and ethnicity.
9. Diversity and inclusion principles will be applied to the entire employment cycle being recruitment, retention, training and development, promotion, succession planning and staff performance.
10. Skillinvest is committed to addressing gender imbalances and promotes flexibility.
11. Skillinvest does not tolerate or condone discrimination, victimisation or vilification and provides avenues for resolution of these matters.

All Skillinvest employees have the responsibility to:

3. Promote inclusiveness and positive working relationships.
